## RESOLUTION OF THE UPPER LOS ANGELES RIVER AND TRIBUTARIES WORKING GROUP APPROVING AND ADOPTING THE UPPER LOS ANGELES RIVER AND TRIBUTARIES REVITALIZATION PLAN, AND RECOMMENDING APPROVAL AND ADOPTION OF THE PLAN TO THE SANTA MONICA MOUNTAINS CONSERVANCY

WHEREAS, the Upper Los Angeles River and Tributaries Working Group was established pursuant to Section 33220 of the Public Resources Code;

WHEREAS, the Working Group is to develop a revitalization plan for the Upper Los Angeles River, and the tributaries of Pacoima Wash, Tujunga Wash, and Verdugo Wash and any additional tributary waterway that the working group determines to be necessary;

WHEREAS, the proposed action is consistent with the Conservancy's Strategic Objective to implement the San Gabriel and Los Angeles Rivers Watershed and Open Space Plan;

WHEREAS, the proposed project is consistent with the San Gabriel and Los Angeles Rivers Watershed and Open Space Plan;

WHEREAS, the proposed action protects land and water resources; and

WHEREAS, the proposed action is statutorily exempt from the provisions of the California Environmental Quality Act (CEQA) pursuant Section 15262 of the CEQA Guidelines: Now

Therefore Be It Resolved, That the Upper Los Angeles River and Tributaries Working Group hereby:

- 1. FINDS that the proposed action is consistent with the San Gabriel and Los Angeles Rivers Watershed and Open Space Plan as adopted by the Santa Monica Mountains Conservancy;
- 2. FINDS that the proposed action is consistent with the Conservancy's Strategic Objectives;
- 3. FINDS that the proposed action is exempt from the provisions of the California Environmental Quality Act (CEQA);
- 4. ADOPTS the staff report and recommendations dated April 16, 2020 for this item;
- 5. ADOPTS the Upper Los Angeles River and Tributaries Revitalization Plan;
- 6. RECOMMENDS that the Santa Monica Mountains Conservancy adopt the Upper Los Angeles River and Tributaries Revitalization Plan;
- 7. FURTHER AUTHORIZES the Executive Director to perform any and all acts necessary to carry out this resolution; without limiting the generality of the foregoing, such authority shall include those provisions that he shall determine

in the exclusive exercise of his discretion are necessary to carry out the purposes of this resolution and to comply with the policies of the Conservancy, and to otherwise carry out the provisions of state law and regulations.
