RESOLUTION OF THE SANTA MONICA MOUNTAINS CONSERVANCY AUTHORIZING
(A) TWO TRANSFERS OF JURISDICTION (TOJ) FROM SEPULVEDA PASS BEL
AIR CREST OPEN SPACE DEDICATION PARCELS (APNS 4377-001-901 AND
4377-001-903) TO THE CALIFORNIA DEPARTMENT OF TRANSPORTATION
(CALTRANS) NOT TO EXCEED 1.0 AND 0.2 ACRES, RESPECTIVELY;
(B) TWO TEMPORARY CONSTRUCTION EASEMENTS AND
ONE PERMANENT DRAINAGE EASEMENT ON SAID PARCELS
TO CALTRANS, AND (C) ACCEPTANCE OF FUNDS FOR SAID
TOJS AND EASEMENTS AND REQUIRED COMPENSATION
AND GRANT SOURCE REIMBURSEMENT FOR THE
LOSS OF THE PARK FACILITIES AT GETTYVIEW
TRAILHEAD AND SKIRBALL CENTER
DRIVE, CITY OF LOS ANGELES

WHEREAS, The California Department of Transportation (Caltrans) is proceeding with widening the 405 Freeway adjacent to Conservancy-owned property in the Sepulveda Pass; and

WHEREAS, The staff report dated April 26, 2010 further describes the project; and

WHEREAS, The proposed actions are exempt from the provisions of the California Environmental Quality Act (CEQA) or have been addressed in a certified Final EIR/EIS prepared by Caltrans; Now

Therefore Be It Resolved, That the Santa Monica Mountains Conservancy hereby:

1. FINDS that its parkland and park improvements in the subject area are valuable public resources and any detrimental impacts from the 405 widening project must be adequately mitigated.
2. FINDS that the proposed actions are exempt from the provisions of the California Environmental Quality Act (CEQA) or have been addressed in a certified Final EIR/EIS prepared by Caltrans.
3. ADOPTS the staff report and recommendation dated April 26, 2010.
4. AUTHORIZES two Transfers of Jurisdiction (TOJ) from Sepulveda Pass Bel Air Crest open space dedication parcels (APNs 4377-001-901 and 4377-001-903) to the California Department of Transportation (Caltrans) not to exceed 1.0 and 0.2 acres, respectively.

5. AUTHORIZES transfer two temporary construction easements and one permanent drainage easement on said parcels to Caltrans.
6. AUTHORIZES acceptance of funds for said TOJs and easements and required compensation and grant source reimbursement for the loss of the park facilities at Gettyview Trailhead and Skirball Center Drive.
6. FURTHER AUTHORIZES the Executive Director to perform any and all acts necessary to carry out this resolution; without limiting the generality of the foregoing, such authority shall include those provisions that he shall determine in the exclusive exercise of his discretion are necessary to carry out the purposes of this resolution and to comply with the policies of the Conservancy, and to otherwise carry out the provisions of state law and regulations.
