RESOLUTION OF THE SANTA MONICA MOUNTAINS CONSERVANCY AUTHORIZING A GRANT OF PROPOSITION 84 AND/OR PROPOSITION 50 FUNDS TO THE MOUNTAINS RECREATION AND CONSERVATION AUTHORITY FOR PROJECT PLANNING AND DESIGN SERVICES FOR THE LECHUZA BEACH PUBLIC ACCESS IMPROVEMENTS PROJECT, CITY OF MALIBU

WHEREAS, The Santa Monica Mountains Conservancy is authorized to award grants to government agencies pursuant to Sections 33204(c), 33204.2, and 33204.27 of the Public Resources Code; and Section 79570 of the Water Code; and

WHEREAS, The State of California has authorized the expenditure of funds from the Water Security, Clean Drinking Water Coastal and Beach Protection Act of 2002 (Proposition 50), Sections 79570(c) to the Santa Monica Mountains Conservancy for purpose of protecting coastal watersheds, including but not limited to, acquisition, protection, and restoration of land and water resources and associated planning, permitting, and administrative costs; and

WHEREAS, the Mountains Recreation and Conservation Authority has made a request for a grant from Proposition 50, Chapter 10, Section 79570(c); and

WHEREAS, The proposed project would promote public access at the publicly-owned Lechuza Beach for people of all abilities; and

WHEREAS, The proposed action is exempt from the provisions of the California Environmental Quality Act (CEQA); Now

Therefore Be It Resolved, That the Santa Monica Mountains Conservancy (Conservancy) hereby:

- 1. FINDS that the proposed action is exempt from the provisions of CEQA.
- 2. ADOPTS the staff report and recommendation dated January 24, 2011.
- 3. AUTHORIZES a grant of Proposition 50 funds to the Mountains Recreation and Conservation Authority in an amount not to exceed \$83,000 for Project Planning and Design services for the Lechuza Beach Public Access Improvements Project, City of Malibu.
