## Resolution No. 11-66

## RESOLUTION OF THE SANTA MONICA MOUNTAINS CONSERVANCY AUTHORIZING A GRANT FROM THE CONSERVANCY FUND TO THE FELIDAE CONSERVATION FUND FOR MOUNTAIN LION AND WILDLIFE CORRIDOR INTERPRETIVE VIDEO

WHEREAS, The Santa Monica Mountains Conservancy is authorized to award grants to nonprofit organizations qualified as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1954, pursuant to Section 33204.2(a) of the Public Resources Code; and

WHEREAS, The Felidae Conservation Fund is a qualified nonprofit organization; and

WHEREAS, The Santa Monica Mountains Conservancy supports the preservation of wildlife habitat linkages and the species that depend upon viable habitat; and

WHEREAS, The Santa Monica Mountains Conservancy supports the efforts of the National Park Service and other agencies to document mountain lion and other wildlife movement; and

WHEREAS, The Santa Monica Mountains Conservancy supports programs to increase public awareness of the wildlife resources and preservation issues in the greater Los Angeles/Ventura Counties region for the purposes of resource stewardship, public access to parklands, and environmental education; and

WHEREAS, The staff report dated August 29, 2011 further describes the project; and

WHEREAS, The proposed action is categorically exempt from the provisions of the California Environmental Quality Act (CEQA); Now

Therefore Be It Resolved, That the Santa Monica Mountains Conservancy hereby:

- 1. FINDS that the proposed action is consistent with the Santa Monica Mountains Conservancy Comprehensive Plan and Conservancy Strategic Objectives.
- 2. FINDS that the proposed action is categorically exempt from the provisions of the California Environmental Quality Act.
- 3. ADOPTS the staff report and recommendation for this item, dated August 29, 2011.

- 4. AUTHORIZES a grant from the Conservancy Fund to the Felidae Conservation Fund in an amount not to exceed \$6,500.00 to produce a video that may be used for educational interpretation programs.
- 4. FURTHER AUTHORIZES the Executive Director to execute the agreement and to perform any and all acts necessary to carry out this resolution; without limiting the generality of the foregoing, such authority shall include those provisions that he shall determine in the exclusive exercise of his discretion are necessary to carry out the purposes of this resolution and to comply with the policies of the Conservancy, and to otherwise carry out the provisions of state law and regulations.
