Project planning and design work and expenses for the Little Sycamore to Encinal Canyon Coastal Slope trail zone project in the Santa Monica Mountains in both the City of Malibu and unincorporated areas of Los Angeles and Ventura counties.

Funding Source Applied for: Proposition 84 Coastal Watersheds

## Narrative/Project Description:

The Coastal Slope trail zone between Little Sycamore Canyon in Point Mugu State Park and the Los Angeles County-owned Banyon project open space dedication in Encinal Canyon contains great potential for rapid and substantial gains on trail implementation. The proposed trail corridor also serves as an important east-west habitat linkage in the Santa Monica Mountains. Maximizing the value of existing and future parklands in this zone requires the implementation of the Coastal Slope Trail.

The proposed project area included under this grant application encompasses approximately 13.5 miles of blue line streams including the creeks of Big Sycamore Canyon, Little Sycamore Canyon, Trancas Canyon, Deer Canyon, Los Alisos Canyon, Nicholas Canyon, Encinal Canyon, and Arroyo Sequit. Within the project area are approximately 80 undeveloped private parcels, totaling approximately 3,000 acres along or buffering the planned Coastal Slope Trail in the Santa Monica Mountains. These parcels potentially include approximately 9.5 miles of Coastal Slope Trail segments. These parcels are separated at different points by Leo Carillo State Park and Charmlee Park. Point Mugu State Park abuts the western terminus of this project area. The project area would exist on both sides of the Los Angeles County-Ventura County line. The area is accessible via Mulholland Highway, Encinal Canyon Road, Yerba Buena Road, Deer Creek Road, and Decker Canyon Road.

The attached aerial photograph shows the parcel specific boundaries of the proposed project area. The Mountains Recreation and Conservation Authority (MRCA) proposes to conduct planning and design work to acquire easements and fee simple parcels in this defined project area.
