REQUESTED ACTION:

The Zoning Administrator will consider:

1. Pursuant to the provisions of Section 12.28-A of the Los Angeles Municipal Code, a Zoning Administrator's Adjustment from Section 12.07.01-C,4 to allow a reduced lot area of 9,959 square feet in lieu of the 11,000 square feet of lot area normally required by the RE11-1 Zone. The reduced lot area of proposed "Lot 2" represents a reduction of less than 20 percent.

 Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA. The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
