## Resolution No. 13-61

RESOLUTION OF THE SANTA MONICA MOUNTAINS CONSERVANCY AUTHORIZING A GRANT OF DEPOSITED MITIGATION FUNDS FROM THE SANTA MONICA MOUNTAINS CONSERVANCY FUND TO THE MOUNTAINS RECREATION AND CONSERVATION AUTHORITY, AND AUTHORIZING AN ADVANCE OF SAID FUNDS, FOR IMPLEMENTATION OF THE CARBON CANYON RIPARIAN HABITAT MITIGATION PROJECT IN THE CARBON CANYON WATERSHED, UNINCORPORATED LOS ANGELES COUNTY

WHEREAS, The Santa Monica Mountains Conservancy is authorized to award grants to government agencies pursuant to Sections 33204.2 (a) and 33204.27(a) of the Public Resources Code; and

WHEREAS, Restoration mitigation funding is available in the Santa Monica Mountains Conservancy Fund from ILF-CDFW-1600-2011-0152-R5 for habitat restoration and enhancement in the Santa Monica Mountains; and

WHEREAS, The Mountains Recreation and Conservation Authority owns and maintains the subject mitigation property on APNS 4453-016-008 and 4453-020-008, within the Coastal Zone portion of the Santa Monica Mountains; and

WHEREAS, The Mountains Recreation and Conservation Authority has requested a grant in the amount of \$116,000 from the Santa Monica Mountains Conservancy Fund; and

WHEREAS, The staff report dated July 22, 2013 further describes the project; and

WHEREAS, The proposed action is exempt from the provisions of the California Environmental Quality Act (CEQA); Now

Therefore Be It Resolved, That the Santa Monica Mountains Conservancy hereby:

- 1. FINDS that the proposed action is exempt from the provisions of the California Environmental Quality Act (CEQA).
- 2. FINDS that the proposed action is consistent with the *Santa Monica Mountains Comprehensive Plan*.

- 3. ADOPTS the staff report and recommendation dated July 22, 2013.
- 4. AUTHORIZES a grant of the Santa Monica Mountains Conservancy Fund to the Mountains Recreation and Conservation Authority in an amount not to exceed \$116,000 to implement a riparian restoration project associated with ILF-CDFW-1600-2011-0152-R5 in the Santa Monica Mountains.
- 5. AUTHORIZES an immediate advance of funds in an amount not less than \$58,000 to allow the Mountains Recreation and Conservation Authority to do the necessary design and mobilization to begin the project.
- 6. AUTHORIZES further advances as submitted in writing by the Mountains Recreation and Conservation Authority and approved by staff, commensurate with project progress.
- 7. FURTHER AUTHORIZES the Chairperson to execute the grant agreement and to perform any and all acts necessary to carry out this resolution; without limiting the generality of the foregoing, such authority shall include those provisions that he shall determine in the exclusive exercise of his discretion are necessary to carry out the purposes of this resolution and to comply with the policies of the Conservancy, and to otherwise carry out the provisions of state law and regulations.
