## Resolution No. 14-54

RESOLUTION OF THE SANTA MONICA MOUNTAINS CONSERVANCY SUPPORTING LOS ANGELES COUNTY PROPOSITION P, SAFE NEIGHBORHOOD PARKS, GANG PREVENTION, YOUTH/SENIOR RECREATION, BEACHES, AND WILDLIFE PROTECTION MEASURE OF 2014.

WHEREAS, Proposition P aims to continue the funding for programs established under the 1992 and 1996 Proposition A measures for the development, acquisition, improvement, restoration, rehabilitation, and maintenance of parks, recreational, cultural, and community facilities, as well as open space lands within Los Angeles County;

WHEREAS, The Los Angeles County Board of Supervisors have authorized The Safe Neighborhood Parks, Gang Prevention, Youth/Senior Recreation, Beaches, and Wildlife Protection Measure of 2014 to be placed before the voters on November 4, 2014;

WHEREAS, If approved, Proposition P would levy a Parcel Tax on each parcel in Los Angeles County for 30 years, generating an approximate total of \$1,627,458,840;

WHEREAS, voter approval of this measure will provide funding for programs throughout the County for the development, acquisition, improvement, restoration, rehabilitation, and maintenance of much-needed parks and other community facilities and open space; Now

Therefore Be It Resolved, That the Santa Monica Mountains Conservancy hereby:

- 1. FINDS that this resolution is consistent with the Santa Monica Mountains Comprehensive Plan, the Rim of the Valley Corridor Plan, and the San Gabriel and Los Angeles River Watershed and Open Space Plan as adopted by the Santa Monica Mountains Conservancy.
- 2. FINDS that this resolution is exempt from the provisions of the California Environmental Quality Act.
- 2. ADOPTS the staff report and recommendations dated September 22, 2014.
- 3. ADOPTS a position supporting Proposition P, The Safe Neighborhood Parks, Gang Prevention, Youth/Senior Recreation, Beaches, and Wildlife Protection Measure of 2014 to be placed before the voters on November 4, 2014;
- 4. AUTHORIZES the Executive Director to do any and all acts necessary to carry out this resolution.
