It is one of our main goals to ensure that sufficient continuity of habitat can be preserved to maintain a functioning wildlife corridor within this area.

The bobcat population is considered one of the umbrella species in this ecosystem, where they have a direct impact on regulating the populations of rodents and other small mammals. Protecting their population would play an integral role in preserving the well-being and health of this ecosystem, which is primarily surrounded by highly urbanized developments. Located near the Cleveland National Forest, this wildlife corridor is capable of sustaining or connecting habitat for large mammals, and threatened and endangered species. Extending protection to the bobcat population under AB 1213 in this wildlife corridor would allow for bobcats to utilize this natural area as part of their habitat without concern to their livelihood.
