**1. Call to order.**

The 433<sup>rd</sup> meeting of the Santa Monica Mountains Conservancy and Santa Monica Mountains Conservancy Advisory Committee was called to order by Acting Chairperson Jerome C. Daniel, at 7:31 p.m. on October 24, 2016 at the Los Angeles River Center and Gardens, Los Angeles, California.
