RESOLUTION OF THE GOVERNING BOARD OF THE SANTA CLARITA WATERSHED RECREATION AND CONSERVATION AUTHORITY AUTHORIZING PARTIAL ASSIGNMENT OF LOS ANGELES COUNTY PROPOSITION A SERVICING AND MAINTENANCE FUNDING TO THE MOUNTAINS RECREATION AND CONSERVATION AUTHORITY TO MANAGE SANTA CLARITA WATERSHED RECREATION AND CONSERVATION AUTHORITY-OWNED PROPERTIES

Resolved, That the Governing Board of the Santa Clarita Watershed Recreation and Conservation Authority hereby:

- 1. FINDS that the proposed action is categorically exempt from the California Environmental Quality Act; and
- 2. FINDS that the Mountains Recreation and Conservation Authority is the most qualified entity to provide servicing and maintenance for Santa Clarita Watershed Recreation and Conservation Authority-owned properties; and
- 3. FINDS that SCWRCA owns over a thousand qualifying acres for which there is currently no assigned management entity; and
- 4. ADOPTS the staff report and recommendation dated January 15, 2019; and
- AUTHORIZES assignment of 2018 Los Angeles County Proposition A Servicing and Maintenance funding to the Mountains Recreation and Conservation Authority (MRCA) to manage eligible Santa Clarita Watershed Recreation and Conservation Authority-owned properties for a period of ten years; and
- CERTIFIES that such funds shall be used only to maintain and service projects funded by the Los Angeles County Regional Park and Open Space District, inclusive of grants issued pursuant to the 1992 and 1996 Propositions; and
- 7. CERTIFIES that such funds shall not be used to fund existing levels of service, but rather only to supplement or enhance existing service levels; and

- 8. AUTHORIZES entering into an agreement with the MRCA to provide such servicing and maintenance funding; and
- 9. AUTHORIZES the Executive Officer, or his assignee, to do any and all acts necessary to carry out this resolution and any recommendations made by the Governing Board.
