MINUTES OF THE JOINT MEETING of the SANTA MONICA MOUNTAINS CONSERVANCY and the SANTA MONICA MOUNTAINS CONSERVANCY ADVISORY COMMITTEE

December 5, 2011

1. Call to order.

The 385th joint meeting of the Santa Monica Mountains Conservancy and Santa Monica Mountains Conservancy Advisory Committee was called to order by Vice Chairperson Jerome C. Daniel, at 7:42 p.m. on December 5, 2011 at King Gillette Ranch, 26800 Mulholland Highway, Calabasas, California.

2. Roll Call of Conservancy.
