MINUTES OF THE JOINT MEETING of the SANTA MONICA MOUNTAINS CONSERVANCY and the SANTA MONICA MOUNTAINS CONSERVANCY ADVISORY COMMITTEE

February 27, 2012

1. Call to order.

The 387th joint telephonic meeting of the Santa Monica Mountains Conservancy and Santa Monica Mountains Conservancy Advisory Committee was called to order by Chairperson Elizabeth A. Cheadle, at 7:37 p.m. on February 27, 2012 at King Gillette Ranch, Calabasas, California.
